Robert Bracker Elementary School and Desert Shadows Middle School are located outside the City of Nogales limits but within Santa Cruz County. Challenger Elementary is located on the other side of railroad crossing that is adjacent to the Grand Avenue.
- 10. Our existing solution has both aerial and underground fiber. It is estimated that 70 % is aerial and 30% is underground. The vendor is responsible to contact the Electric Company Unisource Electric to inquire on Pole Capacity Space.
